NEW BUSINESS

- ➤ **State Commission:** Darlene McMartin announced that she is now a member for the State Commission representing the Veteran At Large. It is a 4 year appointment
- ➤ **Boy Scout Food Drive:** The collection of food is April 13 and will be brought to the office. The office will provide lunch for the troop
- ➤ Honor Flight Iowa and Nebraska: 2 Groups the Nebraska group is for Purple Heart and Bronze Star recipients and the Iowa group is for Vietnam Veterans. Darlene McMartin has been asked to go on the Iowa flight as a guardian
- ➤ 22 Veterans Suicide Awareness Association: Kyle Maher the director of the project is going to assist in setting up the 660 flag displays in each Pottawattamie County Community. The Iowa Veteran's Foundation is going to assist with the purchase of some of the flags.
- ➤ Community Foundation: The Community Foundation reported that there is \$594.90 in interest to be distributed to our office, a discussion was held by the Commission in regards to the use of those funds before the end of the fiscal year 2018-2019 (June 30, 2019). It was determined that since there is no immediate project for the funds to be utilized the funds should be rolled over into the IA Veteran's Foundation to be utilized at a later date.
