## 2. SCHEDULED SESSIONS

Discussion was held with Dean Fajen, Project Manager with HGM Associates, Inc., Buildings and Grounds Director Jason Slack, Chief Information Officer David Beyer, Director of Community Services Suzanne Watson, and other department heads, concerning phasing of the Courthouse Renovation Project. This was a discussion only. No action was taken.

After discussion was held by the Board, a Motion was made by Belt, and seconded by Drake, to approve and authorize Chairman to sign Agreement between Pottawattamie County and The Franks Design Group, P.C., regarding the Community Development Block Grant for the Downtown Revitalization projects for Macedonia and Carson. UNANIMOUS VOTE. Motion carried.

Sam Stivers, Administrative Director of Conservation, and Members of the Countywide Tourism Promotion Committee came before the Board to give an update on the Countywide Tourism, to present Tourism Award for Outstanding Website, to discuss the Trail Launch Bus Tour, to discuss on the Metropolitan Area Tourism Awards, and to give an update on their facts and figures. This was a discussion only. No action was taken.

Motion by Belt, second by Drake, to approve and authorize Board to sign **Resolution No. 20-2019**, a Resolution to waive the filing fee for zoning permits, building permits, septic permits, well permits, floodplain development permits due to the March 2019 flooding in the unincorporated areas of the County. Said Resolution is set out as follows:

#### RESOLUTION NO. 20 – 2019

**WHEREAS**, in March of 2019, several locations in Pottawattamie County, Iowa, endured extreme events of flooding; and

**WHEREAS**, as a result of this extreme event, extensive flooding occurred in the unincorporated areas of the County; and

**WHEREAS**, said flooding has damaged several structures in the unincorporated areas of the County; and

**WHEREAS**, Pottawattamie County has enacted a Zoning Ordinance, Building Code Septic Regulations, Well Regulations and Floodplain Management Ordinance, all of which require that permits be obtained prior to commencing construction or reconstruction; and

**WHEREAS**, Chapter 1.50 of the County Code establishes filing fees for permits required by said Ordinance; and

**WHEREAS**, the Board of Supervisors feels it is in the best interest of the County and those property owners affected, that the filing fees for these permits to be temporarily waived.

**NOW, THEREFORE, BE IT RESOLVED, by the Pottawattamie County, Iowa, Board of Supervisors**, that the filing fees for Zoning Permits, Building Permit, Septic Permits, Well Permits, Floodplain Development Permit shall be waived in the following situations and subject to the following conditions:

- 1. The property is located in the flood inundation areas of the unincorporated area of Pottawattamie County, Iowa.
- 2. The structural repairs are necessary to repair flood damage occurring during the March 2019 flood event.
- 3. That any structural repairs or construction not flood damage related shall be subject to the required filing fees.
- 4. That the waiving of filing fees does not waive any other requirements of Pottawattamie County, Iowa, Code sections.

Motion by Belt, second by Grobe, to approve and authorize Board to sign **Resolution No. 21-2019**, entitled Resolution for the Destruction of Noxious Weeds. Said Resolution is set out as follows:

#### **RESOLUTION NO.** 21 – 2019 **RESOLUTION FOR THE DESTRUCTION OF NOXIOUS WEEDS**

**NOTICE TO ALL PROPERTY OWNERS AND THOSE IN CONTROL THEREOF:** You are hereby notified that the Board of Supervisors of Pottawattamie County, Iowa, did on **the 26<sup>th</sup> day of March**, pass the following resolution:

**BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF POTTAWATTAMIE COUNTY, IOWA**, that pursuant to the provisions of Chapter 317.14, Code of Iowa, it is hereby ordered:  That each person in possession or control of all noxious weeds thereon as defined in this Chapter, at such times each year and in such a manner as shall prevent said weeds from blooming or coming to maturity, and shall keep lands free from such growth of any other weeds, as shall render the streets and highways adjoining said land unsafe for public travel. Noxious weeds shall be controlled, cut or otherwise destroyed between April 1 and November 15, 2019, as is necessary to prevent seed production.

PRIMARY NOXIOUS WEEDS: QUACK GRASS, PERENNIAL SOW THISTLE, CANADA THISTLE, BULL THISTLE, FIELD BINDWEED, HORSE NETTLE, LEAFY SPURGE, PERENNIAL PEPPER-GRASS, RUSSIAN KNAPWEED, BUCKTHORN, MUSK THISTLE, TALL THISTLE, PALMER AMARANTH SECONDARY NOXIOUS WEEDS: BUTTERPRINT ANNUAL, COCKLEBUR ANNUAL, WILD MUSTARD ANNUAL, WILD CARROT BIENNIAL, BUCKHORN PERENNIAL, SHEEP SORREL PERENNIAL, SOUR DOCK PERENNIAL, SOUR DOCK PERENNIAL, SMOOTH DOCK PERENNIAL, POISON HEMLOCK, MULTIFLORAL ROSE, WILD SUNFLOWER, PUNCTURE VINE ANNUAL, TEASEL BIENNIAL, SHATTERCANE ANNUAL

- 2. That each owner and each person in possession or control of any land in Pottawattamie County, Iowa, infested with any Primary and Secondary Noxious Weed, and all other species of thistles belonging to the genera of Cirsium and Carduus, shall adopt or enter into a program of weed destruction, and treatment of control, described by the Weed Commissioner, which in five years may be expected to destroy and will immediately keep under control such infestation of said noxious weeds.
- 3. That all weeds other than noxious weeds on all county trunk and local county roads between the fence line thereof, shall be destroyed and controlled by the adjoining property owner, to prevent seed production.
- 4. That if the owners or persons in possession or control of any land in Pottawattamie County fails to comply with the foregoing order, the Weed Commissioner shall cause this to be done and the expense of said work, including cost of serving notice and other costs, if any, to be assessed against the land and their owners thereof.
- That the County Auditor be and is hereby directed to cause notice of this making and entering of the foregoing order shall be given by one publication in each of the official newspapers of the County.

#### **RESOLUTION NO. 19-2019**

A RESOLUTION OF THE BOARD OF SUPERVISORS OF POTTAWATTAMIE COUNTY NOT TO ALLOW TAX EXEMPTIONS UNDER IOWA CODE SECTION 427.1(22).

- WHEREAS, Iowa Code Section 427.1(22) provides for the Board of Supervisors to designate and grant property tax exemptions for natural conservation or wildlife areas; and
- WHEREAS, Iowa Code Section 427.1(22)(f) does not require the Board of Supervisors to grant such property tax exemptions; and
- WHEREAS, Iowa Code Sections 427.1(23) and 427.1(24) provide procedures to obtain tax exemptions for property certified by the department of natural resources as native prairie, wetland, or wildlife habitat;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF POTTAWATTAMIE COUNTY:

No property tax exemptions shall be granted under Iowa Code Section 427.1(22) for tax year 2019 - 2020 (assessment date January 1, 2019).
