WHEREAS, pursuant to Chapter 423B of the Code of Iowa, 2019, as amended, and an election duly held in accordance therewith, the Board of Supervisors of the County of Pottawattamie (the "Issuer") is currently entitled to receive proceeds of the local option sales and services tax (the "Local Option Tax") imposed in accordance with Chapter 423B and an Ordinance duly adopted by the Board of Supervisors of Pottawattamie County with respect thereto; and

WHEREAS, pursuant to an election held November 8, 1994 and an Ordinance No. 95-2 passed and approved by this Board of Supervisors on February 22, 1995 and published on March 2, 1995, revenues derived from the Local Option Tax are to be allocated as follows: 15% for property tax relief (the "Property Tax Relief Portion"); 70% for secondary roads capital improvements; 10% for soil and water conservation districts for capital improvements; and 5% County Conservation Department; and

WHEREAS, the 70% of local option revenues allocated for "secondary roads capital improvements" is the "Designated Project Portion" proposed to be used for the present project; and

WHEREAS, the Issuer proposes to apply the Designated Project Portion of the Local Option Tax to pay the cost of acquisition of land and construction and equipping of county shops to service secondary roads as determined by the Pottawattamie County Board of Supervisors; and

WHEREAS, the Board now deems it in the best interests of the County and its residents to issue not to exceed \$8,000,000 General Obligation Local Option Sales and Services Tax Bonds, to pay the cost of acquisition of land and construction and equipping of county shops to service secondary roads; and

WHEREAS, before said Bonds may be issued, it is necessary to comply with the provisions of Chapter 423B of the Code of Iowa, and to publish a notice of the proposal to issue such Bonds and the right to petition for an election and to receive oral or written objections from any resident or property owner of the County to such actions.
