The Board of Supervisors met in regular session at 10:00 A.M. All members present, until Grobe left at 1:00 PM. Chairman Schultz presiding.

PLANNING AND ZONING RESOLUTION NO. 2020-08

WHEREAS, the proposed preliminary plat and supporting documents for Gillett Subdivision, a subdivision situated in Garner Township, has been filed with the Pottawattamie County Planning and Zoning Commission for its study and recommendation under Case #SUB-2020-03; and

WHEREAS, said Commission conducted a public hearing on June 15th, 2020, in accordance with Chapter 9.04 of the Pottawattamie County, Iowa, Code and Chapter 354, Code of Iowa, and has given all parties an opportunity to be heard; and

WHEREAS, after careful study and being thoroughly familiar with the involved real estate and the surrounding area, said Commission has submitted its written recommendation to this Board to approve the preliminary plat; and

WHEREAS, this Board conducted a public hearing on July 14th, 2020 in accordance with the above-noted Ordinance and Statute, and has examined the proposed preliminary plat; and

WHEREAS, after careful study, and due consideration this Board has determined that the proposed preliminary plat conforms to the requirements of Chapter 9.01-9.30. Subdivision Ordinance of the Pottawattamie County, Iowa, Code; the Pottawattamie County, Iowa, Land Use Plan and Chapter 354, Code of Iowa, and has deemed it to be in the best interest of Pottawattamie County, Iowa, to concur with the County's Planning and Zoning Commission's recommendation:

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF POTTAWATTAMIE COUNTY, IOWA: That the proposed preliminary plat of Gillett Subdivision, be, and the same is hereby approved as the preliminary plat of said subdivision.

Provided however, that this Resolution shall not be construed as being a final acceptance or approval of said Plat with the meaning of Chapter 9.01-9.30, Subdivision Ordinance, of the Pottawattamie County, Iowa, Code and Chapter 354, Code of Iowa; that after completion of all improvements and satisfaction of all requirements for final plats required by the State and County Ordinances and this Resolution, the final plat shall be submitted to this Board for its consideration.

Sheriff Jeff Danker, Chief Deputy Rob Ambrose, Director of Planning and Development Matt Wyant, and Engineer John Rasmussen came before the Board to discuss passing an ordinance and regulating the operations of all-terrain and off-road vehicles in Pottawattamie County. This was a discussion only. No action was taken.

3. OTHER BUSINESS

After discussion was held by the Board, a Motion was made by Wichman, and seconded by Drake, to approve Pottawattamie County Treasurer's Semi Annual Report for 1/1/2020 - 6/30/2020. UNANIMOUS VOTE. Motion carried.

After discussion was held by the Board, a Motion was made by Wichman, and seconded by Grobe, to approve Employment Agreement between Conservation Director Mark Shoemaker and Pottawattamie County, Iowa (this Agreement corrects the Employment Agreement previously approved on June 16, 2020). UNANIMOUS VOTE. Motion carried.

Motion by Belt, second by Wichman, to approve and authorize Board to sign **Resolution No. 67-2020** (correcting Resolution No. 26-2020 previously passed on March 31, 2020. Said Resolution is set out as follows:

RESOLUTION NO. 67-2020 (correcting Resolution 26-2020)

WHEREAS, the Pottawattamie County Compensation Board meets annually to recommend a compensation schedule for elected officials for the fiscal year immediately following, in accordance with Iowa Code Chapters 331.905 and 331.907; and

WHEREAS, the Pottawattamie County Compensation Board met on the 13th day of December 2019, and recommended a 3.5% increase for all County elected officials, for the fiscal year beginning July 1, 2020; and

WHEREAS, the Pottawattamie County Board of Supervisors, in their meeting on February 11, 2020, discussed and approved to amend the salary increase for the Board of Supervisors to 3%, reduced from the Compensation Board's recommendation of 3.5%. It was further discussed and approved by the Board of Supervisors at that same meeting, that the increase for the remaining elected officials shall remain at Compensation Board's recommendation of 3.5%.

THEREFORE, BE IT RESOLVED that the Pottawattamie County Board of Supervisors hereby adopts the Compensation Board's recommended 3.5% salary increase for all Pottawattamie County elected officials, except for the Board of Supervisors for which they adopt an amended increase of 3%, for the fiscal year beginning July 1, 2020. Said increases shall be as follows:
