#### **NEW BUSINESS**

- ❖ CPR Training: The County/Public Health has offered CPR training to all employees; each department is required to purchase the materials for the class. The Director presented the option to attend to the Commissioners as well.
- ❖ Vehicle Damage/Repair: The Vehicle sustained a rock chip in the windshield @ some point and that repair is happening today. Unfortunately, at Saturdays Outreach Event during the storm/high winds the neighboring booth had its awning pulled off ground and it flew into the passenger rear quarter panel cause a significant scratch. The person in the neighboring booth was holding the awning down and was also pulled into the air and ended up going to the ER after he impacted with the awning. The estimate to repair the scratch is \$813. Insurance covered the windshield but the scratch we will need to pay as our deductible.
- **❖** Significant Retro Active VA Compensation Awards:

100% Schedular Rating from a 10% rating on Appeal back to 7/2019 for a retro benefit of approximately \$66k (Navy Asbestos Claim)

TDIU (100%) from a 90% rating on Appeal back to 6/2014 for a retro benefit of approximately \$114k (Back Injury Claim)

100% Schedular Rating from an 80% rating back to 6/2011 for a retro benefit of approximately \$191k (Blue Water Navy Claim)
