## WAGE REOPENER AGREEMENT

## BETWEEN POTTAWATTAMIE COUNTY, IOWA AND LOCAL 2364, AMERICAN FEDERATION OF STATE, COUNTY, AND MUNICIPAL EMPLOYEES-911 UNION

July 1, 2024-June 30, 2025

Article 13, section 5 of the negotiated contract effective July 1, 2022-June 30, 2025, states: The parties agree to reopen the contract and negotiate for wages only for 2023-2024 and 2024-2025.

The following document provides the agreement of wages for 2024-2025.

## Article 13 Wages

Section 1. Employees shall be compensated in accordance with the wage schedules attached hereto marked Appendix A, herein incorporated by this reference.

Effective July 1, 2024, all Employees represented by the Union who are not on the step and grade, will receive a 5.5% wage increase.

## Article 21 Effective Period

THIS AGREEMENT, shall be effective on July 1<sup>st</sup>, 2024 and shall continue through June 30<sup>th</sup>, 2025.
