One-Time Needy Program:

- Applicant is only eligible for assistance once (1) within a Fiscal Year with the amount of assistance not to exceed \$500.00. Repayment of any prior assistance or good faith effort in repayment is required for future consideration.
- General Assistance is an agency of last resort

Requirements of the One-Time Needy Program:

- Household income must be at or below the 100% Federal Poverty guideline.
- 2. Must have a plan in place to ensure future bills will be paid by the applicant or another source.
- 3. If the need exceeds \$500.00 then the applicant will need to bring in verification that the remaining amount has been paid or payment arrangement with landlord.
- 4. If seeking utility assistance, the number of community volunteer hours is determined by the total amount of the bill divided by 10.
- 5. Proof of monthly household income.
- 6. If need is due to atypical expenses or situation (illness, accidence, robbery) then proof will be required, i.e. doctor's note, police report.
- 7. Apply for any other assistance programs that the applicant may be eligible for.
- 8. Repayment plan for assistance provided must be established

Interim Disability Program:

- Medications up to \$200.00 per month.
- Rental/utility assistance up to \$700.00 per month for a person who has no income or resources in household.
- All household members must qualify for program.
- Personal and household resources must be valued below guidelines.
- Must be unable to work as deemed by their doctor due to a mental or physical illness.
- Must apply for Social Security prior to approval.
- Must have zero income/resources in household

Funeral Assistance:

- Eligible for indigent person who pass away in Pottawattamie County
- Maximum assistance paid to funeral home is \$400.00

General Assistance does *NOT* provide assistance for:

- Utility deposits

- Car payments
- Appliances and other misc. items

Stipulations for <u>ALL</u> General Assistance Programs:

- All other community agencies or benefit program (Medicaid) have been accessed for assistance – General Assistance programs are to be last resort.
- 2. Sign a contract which states that the recipient understands the requirement and expectation of the program, including repayment for funding provided.
- 3. Minors are not eligible unless they are emancipated. Applicants must be lawfully permanent residents.
- 4. Applicant must apply for and comply with all Federal, State and Local program that they are eligible for. Noncompliance or denial of any program is grounds for nonapproval. Applicants must be drug and alcohol free to qualify.

Currently there are funds for deposit and/or 1st month. Requirements for this program vary from typical guidelines as it is through a grant from the Pottawattamie County Housing Trust Fund.

Back-To-Work Program:

- Program continent upon availability of funds
- Assistance for up to three (3) consecutive months not to exceed \$500.00 for a one month period.
- Assistance will not be approved until after successfully completing the month's requirements.
- Program is not meant to supplement income.

Requirements of the Back-to-Work Program:

- 1. Household must be at or below the 100% Federal Poverty Guidelines
- 2. Apply at Vocational Rehabilitation or Workforce Development.
- 3. Must actively seek employment by filling out at least 8 employment applications in one month.
- 4. Attend financial/budgeting class/job fair.
- 5. Must engage in forty (40) hours of community volunteer hours in one month for rental assistance.
- 6. If seeking utility assistance, the number of community volunteer hours is determined by the total amount of the bill divided by 10.
- 7. Comply with treatment recommended by either a physician or GA specialist (i.e. AA meetings, mental health counseling, etc.)
- 8. If the need exceeds \$500.00 then the applicant will need to bring in verification that the remaining portion has been paid or statement of payment agreement with landlord.
