WAGE REOPENER AGREEMENT

BETWEEN POTTAWATTAMIE COUNTY, IOWA AND LOCAL 2364, AMERICAN FEDERATION OF STATE, COUNTY, AND MUNICIPAL EMPLOYEES

July 1, 2024-June 30, 2025

Article 10, Section 7 of the negotiated contract effective July 1, 2022-June 30, 2025, states: The parties agree to reopen the contract and negotiate for wages only for 2023-2024 and 2024-2025.

The following document provides the agreement of wages for 2024-2025.

Article 10 Wages

<u>Section 1.</u> Employees shall be compensated in accordance with the wage schedules attached hereto marked Appendix A, herein incorporated by this reference.

Effective July 1, 2024, Step 1 in all pay grades will increase by \$1.50. Employees will remain in their current step.

Article 12 Effective Period

<u>Section 1.</u> This agreement shall be effective July 1, 2024, and shall remain in full force and effect through June 30, 2025.

<u>Section 2.</u> This agreement shall automatically renew from year to year thereafter, unless either party shall notify the other in writing no later than October 1, of each year that it wishes to modify the agreement.

Section 3. The agreement shall remain in full force and effect while negotiations are in progress.
